Mr. Maurer has hosted over 50 hours of TV shows broadcast on cable in Cleveland and other cities in Northeast Ohio and has appeared in two plays presented by the Cleveland Civil War Roundtable and one at the Huntington Playhouse.



The Hour of Peril by Daniel Stashower— a book review by Tom Horvath



The major contention of this narrative is that there was a very real plot to keep Lincoln from being inaugurated by assassinating him before he reached Washington -- as he travelled between train stations in Baltimore -- and that the plan was foiled by Allen Pinkerton. Despite the many words spent on uncovering and circumventing the plot to kill Lincoln, the thread that runs through this volume is the life of Allen Pinkerton.

The author traces Pinkerton's roots in Scotland, his early life, and his departure for America as a wanted man. He began his new life in Illinois, where he became a successful cooper. His movement into police and detective work was both accidental and pushed upon

him. His early attempts at apprehending criminals were not always successful, but he was persistent.

The investigation into the assassination plot began when Pinkerton was called to the Philadelphia area by Samuel Morse Felton to protect his railroad, the Philadelphia, Wilmington, and Baltimore. Felton received word that, because the railroad was a major link between the north and Washington, D.C., southern radicals were planning on breaking that link. Pinkerton's agency, by this time, was well known for protecting railroad shipments and for his work in tracking down train robbers. He set to work with a number of operatives and in their efforts to uncover plots against the railroad, discovered the plot against Lincoln. By the time Pinkerton was convinced of the seriousness of the plot and discovered the details, Lincoln was already on his way from Springfield. Pinkerton contacted Norman Judd, Lincoln's close friend, who was travelling with him. In Philadelphia, Pinkerton met with Judd and Lincoln to discuss the details of the plot and to propose a change in travel plans that had Lincoln leaving for Washington that day, getting him through Baltimore undetected and earlier than expected.

Lincoln, however, would not be deterred from his final commitments in Philadelphia and Harrisburg the following day, but promised to put himself in Pinkerton's hands once those commitments were fulfilled. Despite that promise, Lincoln entertained second thoughts once in Harrisburg. Then he heard from William Seward, who warned of the same or a similar plot. Still, Lincoln was not convinced until he was satisfied that the two reports were based on separate sources and not one man's story reported through different channels.

Pinkerton, who had been very busy planning while waiting to see Lincoln in Philadelphia, had to change everything. Instead of leaving on a two leg trip from Philadelphia that night, Lincoln would be leaving from Harrisburg on a three leg trip the next day. Pinkerton used his railroad connections to arrange special trains and hold regularly scheduled trains in place until Lincoln arrived. Thus, Lincoln sneaked through Baltimore and arrived early and safely in Washington.

Overall, the book is interesting and well written. In many instances, the author raises questions about the truthfulness of his sources, whether from Pinkerton or others, so he gives the impression of being unbiased. Still, my impression is that information about the Lincoln plot is based primarily on Pinkerton's own accounts – and the author readily admits that Pinkerton wrote several self-promoting books and articles. I say it is "my impression" because there are no footnotes (nor notes section) to indicate sources. Mr. Stashower does mention the source of some of his information within the text, but knowing I could not tie a specific fact or opinion to a specific reference eroded much of my confidence in his assertions.

Published in 2013 by Minotaur Books, the volume contains 354 pages, a select bibliography, and an index. Amazon has the hard cover available for \$16.08 and the Kindle electronic version for \$9.99. Barnes and Noble has the hardcover for \$16.06 and the Nook version for \$12.99. Mentor Public Library has two copies and one copy on CD. The ClevNet System has 42 hard covers, plus six large print books, and twelve audio CDs.
